
SAFETY REGULATIONS FOR EXHIBITORS/COMPETITORS

1. Duty of Care:

All competitors have a “Duty of Care” to avoid exposing themselves or other people to unsafe situations that could lead to injury. The “Duty of Care” extends to the prevention of damage to property.

2. Direction of Korumburra and District Agricultural & Pastoral Society Inc.:

Competitors must comply with any reasonable request of our (K&DA&PS) representatives.

3. Emergency information:

Emergency information and Maps showing Assembly locations have been placed in each of the Pavilions and buildings. Competitors should be familiar with these plans.

4. First Aid:

First Aid will be in the Secretary’s office.

5. Emergency Facilities:

A Defibrillator is in Secretary’s Office.

We collect this information for the purpose of administering The Show. This includes:

- Processing your entry,
- Managing your entry in the relevant event,
- Awarding prizes in relevant event,
- Assessing your compliance with the general regulations and conditions of entry,
- As well as other standards expected of participants in the Show; and
- Assessing any protests or appeals you might make.

We also collect this information for purposes related to the administration of the Show, including:

- Publication of winner’s details,
- Maintenance of information relevant to qualifications for other events,
- Maintenance of records of incidents or accidents that occur at the Show,
- Providing insurance for you during the Show, where applicable,
- Making a claim on our insurance in relation to any incident or accidents in connection with the Show; and
- Passing your information to the Central and South Gippsland (CSGA)

Group of Show Societies and/or the Victorian Agricultural Societies Association Inc. (VASA) should be involved in Group and /or State competition.

Unless you indicate your preference not to receive such material (see below), we may also use your information to update you on coming events to be run by the KDA&PS such as the 2024 Korumburra Show. We may disclose information about you to medical practitioners, St John Ambulance officers and any health service providers attending the Show.

We may disclose information about you to the media for the purpose of publishing articles on participation at the Show.

We may disclose information about you to insurance providers for the purpose of arranging applicable insurance for you or making a claim on KDA&PS insurance in relation to incidents and accidents that occurs at the Show.

We may disclose information about you to the Equestrian Federation of Australia and VAS Ltd. to assess your qualification and eligibility for other events.

If legal, health or safety issues arise, we may be required to disclose information to relevant organisations who deal with these matters.

You have the right to access personal information that we hold about you.
